The Store Front Grant Program helps qualified property owners with grants of up to \$10,000 to improve their property's exterior and facade. Since 2010, the organization has awarded over 200 storefront grants totaling more than \$1,800,000. SAGE also collaborates with community partners to improve and enhance the financial literacy, branding, and marketing of Eastside businesses. SAGE is a resource and catalyst for small businesses operating or desiring to move to San Antonio's growing and redeveloping Eastside.
